1. AIM OF THE AGREEMENT

- 1.1. To determine the conditions under which müller co-ax supplies its Products to the Market on one part and "Distributor's" distributorship on the other part.
- 1.2. The agreement covers the conditions for distribution (sales and service), in the assigned market, for the following products:
 - co-ax valves
 - 2/2 way coaxial direct acting
 - 3/2 way coaxial direct acting
 - 2/2 way coaxial externally controlled
 - 3/2 way coaxial externally controlled
 - certificated valves; cartridge valves
 - lateral valves; high pressure coaxial valves
 - high pressure lateral valves; modules and manifolds
 - pressure control valves; flow control valves
 - special valves;
 - Spares, accessories and services thereofCalled hereafter "**Products**".

2. DISTRIBUTOR'S OBLIGATIONS

- 2.1. The Distributor agrees to promote müller co-ax's Products and find customers in the assigned Market.
- 2.2. The Distributor shall promote and propose the Products according to müller co-ax's technical specifications. Any modification must be authorized by müller co-ax.
- 2.3. Upon request for Products proposals to be delivered outside the country Market, the Distributor shall inform müller co-ax first and ask for authorization.
- 2.4. The Distributor assists müller co-ax's specialists delegated to the Market during their assignment.
- 2.5. The correspondence with müller co-ax will be in English.

3. OBLIGATION OF müller co-ax

- 3.1. müller co-ax shall assist the promotion of its products with:
 - documentation (catalogues, manuals, product presentations, etc.)
 - delegation of its specialized technicians and sales engineers to visit customers, assist in exhibitions and presentations of müller co-ax products as per mutual agreement
- 3.2. müller co-ax shall not appoint any other distributor / representative to promote its products in the market.

4. VALIDITY OF AGREEMENT

- 4.1. The present agreement comes into force on January 2018 and is limited in its duration to five years, i.e. until December 2022. As of this date, the agreement will automatically be renewed on a yearly basis. It can be cancelled by either of the parties, by registered letter with a prior notice of three months.

5. COMMERCIAL CONDITIONS

- 5.1. Orders received for products are valid once müller co-ax confirms it.
- 5.2. Important correspondence between the Distributor and müller co-ax must be duly signed by authorized representatives of both companies.
